

**NOTICE OF PUBLIC HEARING**  
**PROPOSED NEW AND RESTRUCTURED PARKS AND RECREATION FEES FOR FISCAL**  
**YEAR 2023**

NOTICE IS HEREBY GIVEN, that the City Council of the City of Lewiston will hold a public hearing for consideration of proposed new and restructured fees for Parks and Recreation for Fiscal Year 2023, which begins October 1, 2022. Said hearing will be held on the second floor of the Lewiston City Library, 411 D Street, Lewiston, Idaho, at 6:00 p.m., on July 25, 2022.

**The proposed new fees include:**

- Community Center Rental Alcohol Fee of \$30/rental
- Community Center room rate for the Cutthroat Room of \$25/hr
- Community Center room rate for the Salmon Room of \$25/hr
- Community Center room rate for the Steelhead Room of \$30/hr
- Community Center room rate for the Kokanee Room of \$25/hr
- Community Center room rate for the Sturgeon Room of \$25/hr
- Community Center room rate for the Chinook Room of \$20/hr
- Fenton Gym rate of \$30/hr
- Legacy Tree Program for the tree only of \$300
- Legacy Tree Program for the tree and plaque only of \$450
- Legacy Tree Program for the bench only of \$1,200
- Legacy Tree Program for the tree, plaque and bench of \$1,650

**The proposed amended fees include:**

- Park Shelter at Kiwanis, Airport, Hereth and Sunset for small group from \$55 to \$65
- Park Shelter at Kiwanis, Airport, Hereth and Sunset for medium group from \$65 to \$75
- Park Shelter at Kiwanis, Airport, Hereth and Sunset for large group from \$125 to \$135
- Park Shelter at Kiwanis, Airport, Hereth and Sunset for group over 500 from \$200 to \$225
- Band shell at Pioneer Park for small group from \$75 to \$85
- Band shell at Pioneer Park for medium group from \$85 to \$95
- Band shell at Pioneer Park for large group from \$145 to \$155
- Band shell at Pioneer Park for group over 500 from \$200 to \$225
- Park rental with vendor from \$50 to \$75
- General park rental from \$40 to \$50
