Order Terminating Local Disaster Emergency

WHEREAS, on June 9, 2023, a 50-year flash flood event occurred, as a result of a severe thunderstorm releasing more than one half inch (1/2") of rain in less than ten (10) minutes throughout the City of Lewiston;

WHEREAS, localized flooding during and after the flood event severely damaged roads and public infrastructure, as well as depositing excessive amounts of debris on roadways and in a majority of the City's drainage systems, resulting in multiple roads being closed and a Declaration of Local Disaster Emergency to be issued by the Mayor of the City of Lewiston on June 14, 2023, which Declaration of Local Disaster Emergency was recorded with the Nez Perce County Recorder as Instrument No. 908108 (hereafter "Declaration of Local Disaster Emergency");

WHEREAS, on June 21, 2023, the Lewiston City Council passed Resolution 2023-31, consenting to the continuance of the Declaration of Local Disaster Emergency beyond seven (7) days of its inception, in accordance with Idaho Code § 46-1011, which was recorded with the Nez Perce County Recorder as Instrument No. 908282;

WHEREAS, the City of Lewiston has completed comprehensive cleanup and necessary repairs to roads and infrastructure; and

WHEREAS, the Mayor now desires to terminate the local disaster emergency that was the subject of the Declaration of Local Disaster Emergency, pursuant to Idaho Code § 46-1011.

NOW, THEREFORE, I, Daniel G. Johnson, Mayor of the City of Lewiston, by virtue of the authority vested in me by Idaho Code § 46-1011, do hereby order as follows:

1. The local disaster emergency that was the subject of the Declaration of Local Disaster Emergency is hereby terminated.

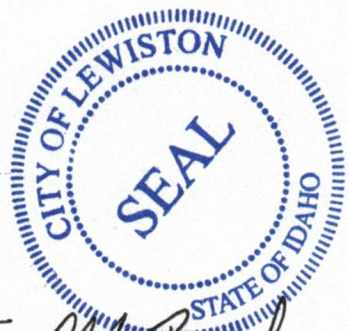
2. This Order shall be given prompt and general publicity and shall be filed promptly with the Nez Perce County Recorder, in accordance with Idaho Code § 46-1011.

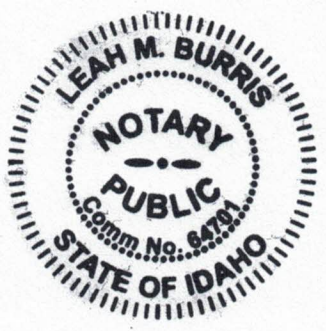
